Criteria

- Is the most improved throughout the year.
- Demonstrates a great willingness to please.
- Has a good temperament.

Conditions

All owners must be fully paid up members of Newfs in Action.

The Officers decision is final.

The recipient is responsible for the trophy, its engraving and safe return either at or before the subsequent AGM.

News In Action - The Boat Jumpers Display Award

This award will be presented annually at the agm. Nominations can be made by the owner and submitted to the Secretary by 31st January. The Chairman, Secretary and Treasurer of News In Action will collectively ratify the nomination and these will be announced at the AGM in March.

Aim

To recognise all members dogs who undertake a boat jump at a display, and produce a full club record of the NIA boat Jumpers.

Criteria

A club member (Newfoundland dog) either Full or FONIA, shall be awarded their name on the annual trophy. A dogs name will appear once with the year that they first contributed a boat jump.

The jump must be a clear Leap from the boat.

At the annual awards time a form will be completed by owners and submitted to the awards committee for verification for their dog to be recognised on this award.

The awards committee will then arrange for the plaques to be displayed and the trophy will be brought to the agm for view and photographs etc.

Should an owner not submit the relevant form the awards committee may still award the plaque. However they are under no obligation to remember every dogs achievements and it is for owners to submit the form for inclusion and verification.

Nomination Procedure

Each nomination form will have a brief explanation of the reason for the proposal and there will be a synopsis of the explanations available at the AGM. The secretary will coordinate the nominations and in the event of a tie there will be a closed vote at the AGM.

3 Special Award

This is a provision that enables a Special Award to take place when appropriate. There is no minimum or maximum number of special awards.

A Special award will be funded from club funds as deemed appropriate by the awards team.

Any special award will be kept by the recipient for life.

There will be a nomination form in the awards booklet should any Full Member wish to bring a special act / reason to the attention of the awards team, and again this can be done at anytime.

There will be a nomination form for this award in the awards book, so that any Full Member of Newfs In Action may suggest a nomination to the awards team.
